

Introduction

This Privacy Statement explains Renova Life Inc.'s commitment not only to your privacy, but to you as a valued customer. To that end, we have created this Privacy Statement to explain the types of personal and non-personal information we collect through the website www.renovalife.com. We will explain how we use this information and to whom and under what circumstances we disclose such information.

Information Collected

Personal Information

In general, we may collect personal information from visitors to the Site if they (1) contact us (including our Webmaster, customer service representatives, or other employees); (2) complete a survey, or feedback; (3) participate in a sweepstakes; (4) make product or service inquiries; or (5) purchase products. In connection with these activities, we may collect personal information, including, but not limited to, name, mailing address, e-mail address, telephone number, fax number, billing address, areas of interest, research interest areas, and name of institution. We may combine visitors' personal information with information that we collect from other online and offline sources. This information may include, for example: (1) information we receive from visitors when they call us, complete our surveys or other forms; (2) information visitors submit to us at our online form or special events; and (3) updated contact and other information about our visitors that we may receive from third parties.

Non-Personal Information

As part of the standard operation of our Site, we may collect information about visitors' browsing behavior, such as the dates and times they visit our Site, the areas or pages of our Site that they visit, the amount of time spent viewing our Site, the number of times the visitor returns to our Site, and other click-stream data.

We may combine the non-personal information that we collect with the personal information that we collect about our visitors.

Use of Information

We may use personal information collected from visitors to our Site for any of the following purposes: (1) to fulfill product orders and requests for information about certain products and services; (2) to contact visitors to our Site when necessary (e.g., to respond to inquiries); (3) to send information, promotional materials, and newsletters from our company; (4) to help address problems with our Site; (5) to conduct internal reviews of our Sites (e.g., to determine the number of visitors to specific pages within the Site); (6) to help us better understand visitors' use of our Site; (7) to protect the security or integrity of our Site; (8) to conduct market research; (9) to customize our Site or marketing communications for our visitors and customers; and (10) to help us provide better products and service to our visitors and customers. Non-personal information will be used for these purposes as well as for conducting internal reviews and monitoring of our Site and providing a greater online experience for our visitors.

Disclosure of Information

We may transfer or otherwise disclose information collected from visitors to our Site for the following purposes: (1) to Renova Life Inc's employees, independent contractors, subsidiaries, affiliates, consultants, business associates, service providers, and suppliers, if the disclosure will enable that party to perform a business, professional, or technical support function for Renova Life Inc; (2) as necessary if Renova Life Inc. has reason to believe that such disclosure is necessary to identify, contact, or bring legal action against someone who may interference with our rights and property, other users of our Site, or anyone else who could be harmed by such activities; (3) to announce the launch of new products and services; and (5) as provided for under the "Unforeseen Circumstances" section below.
